WITH A SAFE AND COMFORTING "HOME AWAY FROM HOME" WHILE THEIR CHILD IS  
RECEIVING TREATMENT AT LOCAL HOSPITALS. FAMILIES RECEIVE A PRIVATE ROOM  
AND BATHROOM, ACCESS TO COMMON AREAS, KITCHEN, LAUNDRY, AS WELL AS HOME  
COOKED MEALS. NO FAMILY IS EVER CHARGED FOR THEIR STAY, SOME LASTING  
MONTHS. IN 2024 THERE WERE 436 FAMILY STAYS WITH AN AVERAGE STAY OF 36
