ADDITIONALLY, THE BEGINNING NET ASSETS WITH DONOR RESTRICTIONS DID NOT RECOGNIZE THE TIME RESTRICTED CONTRIBUTION FOR THE FAIR MARKET VALUE, NET OF DISCOUNT OF THE LONG TERM DONATED USE OF FACILITIES. THIS RESULTED IN THE ADDITION OF THE "DONATED USE OF FACILITIES" ASSET FOR THE REMAINING NET VALUE WITH THE CORRESPONDING NET ASSETS WITH DONOR RESTRICTIONS FOR THE TIME RESTRICTED CONTRIBUTION BEING ADJUSTED. THE TOTAL DONATED USE OF FACILITIES ADJUSTMENT WAS \$1,714,095
