No family is ever charged for their stay, some lasting months.

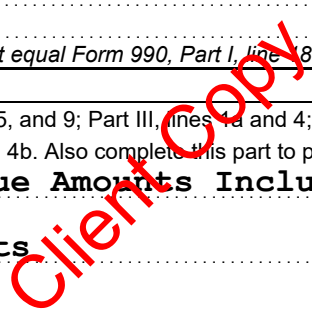
